7	issues of the Nutley Sun, the Herald News, and the

13	COMMISSIONER TUCCI: Here.
14	THE CLERK: Commissioner Evans?
15	COMMISSIONER EVANS: Here.
16	THE CLERK: Commissioner Petracco?
17	COMMISSIONER PETRACCO: Here.
18	THE CLERK: Mayor Scarpelli?
19	MAYOR SCARPELLI: Here.
20	THE CLERK: All present, Mayor, except for
21	Commissioner Rogers. He's absent, excused, this
22	evening.
23	MAYOR SCARPELLI: Thank you, Madam Clerk.
24	Commissioner Petracco, what do you have on the agenda
25	tonight?

1	COMMISSIONER PETRACCO: I have a couple
2	resolutions it looks like. I have this fire truck
3	apparatus on here. I have the grant of a medical
4	leave, a budget transfer of 10,000, and I have the
5	copiers back on, there were three copiers. That's all
6	I have.
7	MAYOR SCARPELLI: Thank you, Commissioner.
8	Commissioner Evans?
9	COMMISSIONER EVANS: I've got just have
10	two resolutions, one for granting of a property tax
11	exemption for a 100 percent disabled veteran, some
12	refunds of overpayments. We have about 8400 bucks in
13	outstanding checks that need to be canceled, they're
14	outstanding for over a year. And a refund on some
15	escrow monies, and a transfer to capital, a budget
16	transfer for (indiscernible).
17	MAYOR SCARPELLI: Commissioner Tucci?
18	COMMISSIONER TUCCI: I have a Shade Tree
19	Report for the month of October, and I have three
20	resolutions. The first one is awarding a contract for
21	insurance, accident and safety review to the C. Walter
22	Searle Agency, not exceeding 10,000. The second is for
23	C. Walter Searle Agency to serve as our risk manager,
24	and the third is authorizing a three-year agreement
25	with Altice Business for internet and long distance

1 phone service. And that's all I have. MAYOR SCARPELLI: Thank you, Commissioner. 2 Let me go through Commissioner Rogers's first, I'll 3 take his. He's got a contract with Northwest Essex for 4 5 \$20,000. He has an authorization to -- with -- for a contract with the New Jersey Association of Retarded 6 7 Citizens, not to exceed 1,000. He has a municipal services agreement solids for Arbor Hills, and then he 8 9 has three resolutions for recognizing Alzheimer's Awareness Month, World Diabetes Day, and National 10 11 Pancreatic Cancer Awareness Month. And I have the authorization for raffles and 12 award of a professional service contract for Pennoni, 13 that's for doing a hydraulic study on our water system 14 15 to see what it would take to get off North Water. So, that's all I have. Madam Clerk? 16 THE CLERK: Yes, Mayor. We have regular 17 18 meeting minutes, and Holy Family Church has submitted a request to have a 50/50 on a Sunday, December 29th. 19 20 And that's it. 21 MAYOR SCARPELLI: Mr. Genitempo? 22 MR. GENITEMPO: I have a matter for 23 executive, also contract negotiations with Joe. 24 MAYOR SCARPELLI: Motion to go into 25 executive.

2	COMMISSIONER PETRACCO: Move it.
3	COMMISSIONER EVANS: Second.
4	THE CLERK: Whereas, Section 8 of the Open

15	Commissioners of the Township of Nutley to move into
16	closed executive session to discuss personnel and
17	contract negotiations. Be it further resolved that at
18	the time when such discussions may be disclosed to the

20	made without adversely affecting the Township of
21	Nutley, pending and/or anticipated legal, personnel,
22	contractual matters, and other matters within the
23	exemption provided for by statute.
