WHEREAS, the Township of Nutley, in the County of Essex, New Jersey (the “Township”) has previously issued its bonds, bond anticipation notes and/or other debt obligations (the “Bonds”); and

WHEREAS, in connection with the issuance of certain of the Bonds and for purposes of assisting underwriters to comply with Rule 15c-12 under the Securities Exchange Act of 1934, the Township has covenanted and/or entered into one or more undertakings or agreements to provide continuing disclosure (the “Continuing Disclosure Obligation”) to the public marketplace; and

WHEREAS the Continuing Disclosure Obligation requires the Township to file certain financial information and notice of certain events in specified places and at specified times; and

WHEREAS, the Township is desirous of retaining a professional firm that specializes in continuing disclosure matters to make the necessary filings at the specified places and specified times as part of the Township’s Continuing Disclosure Obligation;

WHEREAS, funds are available from account no. 0-01-208-205 (Subject to Adoption of the **2020** Municipal Budget) and have been certified by the chief financial officer, said certification being attached to this resolution,

NOW, THEREFORE, BE IT RESOVED, by the Board of Commissioners of the Township of Nutley, County of Essex, New Jersey as follows:

1. The Mayor and Township Clerk are hereby authorized and directed to execute an agreement with NW Financial Group, LLC, 2 Hudson Place, Hoboken, NJ 07030 for the services of **Professional Financial Audit Services** for a total amount not to exceed **\$1,500.00** in accordance with a proposal dated April 10, 2020.
2. This contract is awarded without competitive bidding as a “Professional Service” in accordance with N.J.S.A. 40a11-5(1)(a) of the Local Public Contracts Law because the contract is for a service performed by a person(s) authorized by law to practice a recognized profession that is regulated by law.
3. Notice of this action shall be printed once in the Nutley Sun, the legal newspaper of the Township of Nutley.

WHEREAS, the COVID-19, known as the Coronavirus, has disrupted the lives of all Nutley residents, including families with pets; and

WHEREAS, N.J.A.C. 8.34A-4.1 mandates that the Municipal Clerk can only renew a pet license when the pet has a current or has had an updated rabies inoculation that extends through at least 10 months of the renewal period, in this case February 28, 2021; and

WHEREAS, the Township has had to cancel the free rabies clinics originally scheduled for month of April, 2020 in compliance with the Governor’s executive order establishing strict limitations on large group gatherings; and

WHEREAS, the Township hopes to be able to reschedule the free clinics in the June timeframe; and

WHEREAS, the Township, in light of this Pandemic health crisis, desires to avoid the unnecessary cost and addition financial burden associated with veterinarian visits to obtain a rabies inoculation for their pet; and

NOW, THEREFORE, THE BOARD OF COMMISSIONERS, of the Township of Nutley, in the County of Essex does hereby adopt and authorize the following:

1. The pet license renewal period is hereby extended 90 days to July 31, 2020.
2. The \$10.00 late payment penalty is waived through July 31, 2020.
