ORDINANCE NO. 3450

AN ORDINANCE TO AMEND AN ORDINANCE CODIFIED IN THE CODE OF THE TOWNSHIP OF NUTLEY, CHAPTER 228, ENTITLED VEHICLES AND TRAFFIC, PARTICULARLY ARTICLE XIII (PARKING METER ZONES), SECTION 46 ENTITLED PARKING METER ZONES, TO ADD THE LOCATIONS SET FORTH THEREIN.

BE IT ENACTED by the Board of Commissioners of the Township of Nutley that Article XIII, Section 46 of Chapter 228 of the Code of the Township of Nutley, entitled Parking Meter Zones, is hereby amended to set forth the addition of the following location:

§ 228-46

Parking meter zones.

In accordance with the provisions of § 228-44, parking meter zones are hereby established upon the streets or parts of streets described below. It shall be unlawful on any day, except Sundays and holidays, to park a vehicle in any such zone except upon deposit of the coins indicated for a specified period of time. (All on-street meters operate between the hours of 8:00 a.m. and 6:00 p.m.)
