AN ORDINANCE TO AMEND AN ORDINANCE CODIFIED IN THE CODE OF THE TOWNSHIP OF NUTLEY, CHAPTER 673, ENTITLED VEHICLES, IMPOUNDMENT AND TOWING, PARTICULARLY ARTICLE K ENTITLED TOWING AND STORAGE FEE SCHEDULE TO REVISE TOWING AND STORAGE FEES

BE IT ENACTED by the Board of Commissioners of The Township of Nutley that Section K of Chapter 673 of the Code of the Township of Nutley, entitled Vehicles, Impoundment and Storage, is hereby amended set forth to revise towing and storage fees:
