Commissioner Kelly and the Nutley Department of Public Affairs and Health are proud to announce the official opening of the Nutley Substance Use Disorder Resource Center, located in the Nutley Public Affairs and Health Building, and are honored to partner with RWJMS and the Division of Mental and Addiction Services to present a Free Naloxone/Narcan Zoom Training Course.

### Discount Programs for Property Tax Relief

### • Senior Freeze (Property Tax Reimbursement)

This property tax relief program will reimburse you for any property tax increases you experience once you're in the program. You will get the difference between your base year (first year of eligibility) property tax amount and the current year property tax amount, as long as the current year is higher than the base year and you meet all other eligibility requirements (2022 joint income: \$99,735 / 2023 joint income: \$150,000).

• ANCHOR Program (formerly Homestead Benefit Program)

This program provides property tax relief to New Jersey residents who own or rent property in New Jersey as their principal residence and meet certain income limits.

• \$250 Property Tax Deduction for Senior Citizens & Disabled Persons

An annual \$250 deduction from real property taxes is provided for the dwelling of a qualified senior citizen, disabled person or their surviving spouse. To qualify, you must be age 65 or older, or a permanently and totally disabled individual or the unmarried surviving spouse, age 55 or more, of such person.

- **\$250 Veteran Property Tax Deduction** Honorably discharged veterans who served on active duty in the U.S. Armed Forces may qualify for an annual \$250 property tax exemption on their primary residence. An eligible veteran's surviving spouse or domestic partner is also eligible.
- 100% Disabled Veteran Property Tax Exemption

If you are an honorably discharged veteran who was 100% permanently and totally disabled during active duty service, you may qualify for an annual property tax exemption on your principal or primary residence (main home). If you are a surviving spouse or civil union/ domestic partner of an honorably discharged veteran who was 100% permanently and totally disabled during active duty service, you also may qualify.

- Active Military Service Property Tax Deferment If you are a serviceperson, deployed or mobilized for active service in time of war, you may qualify for a deferment of your property tax bill. You may authorize someone to apply for the deferment on your behalf. Once your deployment/mobilization is over, you have 90 days to pay your deferred property taxes. This deferment does not include any tax payments that were delinquent prior to deployment or mobilization. Interest on late deferral payments will be assessed back to their original due date. Sewer, water, electric and other municipal charges may not be deferred. If there is a mortgage on the property with an escrow account for property tax payments, contact your lender regarding the deferment.
- StayNJ Plan (Coming in January 2026) will provide tax credits worth half of a senior citizen's property tax bill, up to \$6,500 for incomes up to \$500,000.

# **REVENUE AND FINANCE**

### **Tax Assessor's Services** 973-284-4956

The Tax Assessor works independently from the Township reporting directly to the Essex County Board of Taxation. He is responsible for the uniform, fair, objective, and accurate assessments of all real property within the Township. Every property in town has an individual property record card which determines your property's assessed value. If you don't have a copy, it is readily available by contacting the Tax Assessor's office. It is important to always make sure your record is accurate



and up to date. If you have questions about your assessment, we encourage you to contact this office to schedule an appointment.

### Military & Veteran's **Benefit**

If you are in active military service, you are entitled

to a property tax deduction of \$250.Applications are available online at www.nutleynj.org. Disabled veterans who meet the requirements for total disability are exempt from paying property taxes. Our office is honored to assist you to make sure all eligible military members and veterans receive this benefit.

### **Property Tax Relief Programs**

The State of New Jersey offers several programs for property tax relief. You may be eligible for one or more. Each of the above listed benefits have specific eligibility criteria and filing deadlines. Contact the Tax Assessor's office to find out if you qualify for assistance in filling out the applications. ### **Code Enforcement Services** 973-284-4957

The Code Enforcement Department provides many valuable services to assist homeowners in making

improvements to their property and contributes to making sure our Township continues to be a great place to live. l encourage you to contact them whenever vou are thinking about house and yard renovations or additions. Their services are guided



by State construction rules and regulations and the Township of Nutley Code, which regulates zoning, property maintenance, tree removals, soil movement, storm water control and various aspects of construction operations including noise, pollution and when work may be performed.

#### **Construction Permits and Variances**

Remember, permits are required for many improvement projects and at times a variance from our zoning code is needed. When this happens, we will assist you with the application requirements to go before the Zoning Board of Adjustment.

Inspections are scheduled during the following days and times:

### **Property Maintenance**

Our municipal code requires all property owners to keep their property in good condition. All requirements can be found at

www.nutleynj.org. Most notably, it is important to keep grass cut throughout the season and remove snow promptly from sidewalks in the winter.
