## **About the Nutley Water Department and the Sources of Your Drinking Water**

The Nutley Water Department is a division within the Township of Nutley's Department of Public Works, and operates solely on revenue received for the services rendered. This means that tax dollars are not necessary for this utility to function under normal conditions.

Nutley receives the majority of its potable water from the Passaic Valley Water Commission (PVWC). Its main facility is the Little Falls Water Treatment Plant in Totowa, NJ. Water is diverted from the Passaic and Pompton Rivers, is treated, filtered and disinfected at the plant. In drought conditions or other emergencies, water from the Point View Reservoir in Wayne, NJ can be used to supplement river sources. Treated water is then mixed at PVWC's main pumping station with treated water from the North Jersey District Water Supply Commission's Wanaque Reservoir treatment plant. Water is then pumped into underground transmission lines running through Nutley. Nutley has four (4) intake pit areas along this transmission

## Coeyman Avenue • Ridge Road • Centre Street • Meacham Avenue

At these intakes, the water goes into our distribution system. The water is then conveyed into all homes or businesses connected to the system.

The City of Newark serves 436 Nutley households with Pequannock Reservoir Water. This area is located west of Ridge Road and Van Winkle Avenue and bordered by Glenview Road, the Township of Nutley Bloomfield boundary line and East Passaic Avenue.

The Nutley Water Department is a public community water system and purchases water from the following water systems:

#### **Monitoring and Testing of Drinking Water**

The Nutley Water Department routinely monitors for contaminants in your drinking water according to federal and state laws. This report covers the period from January 1, 2024 thru December 31, 2024. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water including bottled drinking water may be reasonably expected to contain at least small amounts of some constituents. It is very important to remember that the presence of these contaminants does not necessarily pose a health risk.

For the year 2024, Passaic Valley Water Commission (PVWC) did all the required testing of our water supply. The Township of Nutley in 2024 sampled and tested water throughout the township for:

- Chlorine Residuals
- Coliforms
- Haloacetic Acids Iron and Manganese · Lead and Copper
- Radionuclides (tested by the State in 2001)
- Trihalomethanes

## **Health and Educational Information**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human

#### Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife
- **Inorganic contaminants,** such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to insure that tap water is safe to drink EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

The standards for these contaminants are known as Maximum Contaminant Levels (MCL's) that are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

### Special Considerations Regarding Children, Pregnant Women, Nursing Mothers, and Others

Children may receive a slightly higher amount of a contaminant present in the water than do adults, on a body weight basis, because they may drink a greater amount of water per pound of body weight than do adults. For this reason, reproductive or developmental effects are used or calculating a drinking water standard, if these effects occur at lower evels than other health effects of concern. If there is insufficient toxicity information for a chemical (for example, lack of data on reproductive or developmental effects), an extra uncertainty factor may be incorporated into the calculation of the drinking water standard, thus making the standard more stringent, to account for additional uncertainties regarding these effects. In the cases of lead and nitrate, effects on nfants and children are the health endpoints upon which the standards are based

#### Additional Information on Lead

f present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with ervice lines and home plumbing. The Nutley Water Department is esponsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ### **Source Water Assessment Summary**

#### A State Review of Potential Contamination Sources Near Your Drinking Water

he New Jersey Department of Environmental Protection (NJDEP) has completed and issued the Source Water Assessment Report and Summan for all public water systems. The Source Water Assessment and related questions can be obtained by logging onto the NJDEP's source water ssessment website at <u>www.nj.gov/dep/watersupply/swap</u> or by contacting the NJDEP's Bureau of Safe Drinking Water at (609) 292-5550. If system is rated highly susceptible for a contamination category, it does not mean a customer is or will be consuming contaminated water. The rating reflects the potential for contamination of source water, not the existence of contamination. Public water systems are required to monitor for regulated contaminants and to install treatment if any contaminants are detected at frequencies and concentrations above allowable levels. The source water assessments performed on the intakes for each system lists the following susceptibility rated as indicated in the following table.

### Cryptosporidium

Cryptosporidium is a microbial pathogen found in surface water throughout the United States. Although filtration removes Cryptosporidium, the most commonly-used filtration methods cannot guarantee 100 percent removal. Our monitoring indicates the presence of these organisms in our source water and/or finished water. Current test methods do not allow us to determine if the organisms are dead or if they are capable of causing disease. Ingestion of Cryptosporidium may cause cryptosporidiosis, an abdominal infection. Symptoms of infection include nausea, diarrhea, and abdominal cramps. Most healthy individuals can overcome the disease within a few weeks. However, immuno-compromised people, infants and small children, and the elderly are at greater risk of developing life-threatening illness. We encourage immuno-compromised individuals to consult their doctor regarding appropriate precautions to take to avoid infection. Cryptosporidium must be ingested to cause disease, and it may be spread through means other than drinking water.

- Some people who drink water containing trihalomethanes in excess of the MCL over many years many experience problems with their liver, kidneys or central nervous systems and may have an increa risk of cancer. We do not add fluoride to your drinking water

November 2024, we became aware that our system failed to collect the correct umber of drinking water samples. Although this incident was not an nergency, as our customers, you have a right to know what happened and what e did to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our inking water meets health standards. During the 1/1/2024 - 06/30/202 ompliance period, we did not complete all monitoring or testing at the Passaid /alley Water Commission's distribution system sampling point (DSWQ1) as required in our Water Quality Parameters sampling plan for our and therefore cannot be sure of the quality of your drinking water during that time.

#### What should I do?

There is nothing you need to do at this time. You may continue to drink the water f a situation arises where the water is no longer safe to drink, you will be notified vithin 24 hours.

## What is being done?

We are working with Passaic Valley Water Commision to install a sampling point at the interconnection where PVWC's water comes into the Nutley system so we can be in compliance.
